**Subject:- Hiring of Taxies for Press Information Bureau - Calling of quotations -Reg.**

Sealed tenders are invited from the reputed Tour and Travel Agencies for preparing a panel for hiring of Taxies for the official use for the Press Information Bureau, Ministry of I&B, Shastri Bhavan, New Delhi. All companies on the panel will have to agree to the lowest bidder's rate. The cars to be provided should not be more than one year old and should not have run more than 20,000 Kms. as on the date of hiring by the Department.

2. The firms may deposit their bids superscribed as "Quotation of Hiring of Taxis" and addressed to Joint Director (Admn.), Room No.713, A Wing, Shastri Bhawan, Press Information Bureau, New Delhi. The bid is to be accompanied by an earnest money deposit of Rs. 2000/- (Rs. Two thousand only) in the form of Demand Draft in favour of DDO(Cash), Press Information Bureau, Shastri Bhavan, New Delhi. The tender without earnest money shall not be accepted.

3. The firms should be located within 6 kms radius of Shastri Bhawan. They should have at least five years of experience in the tour and travel business with at least 10 vehicles with them. At least 2-3 dedicated vehicles and Drivers must be provided since security labels of Shasrti Bhawan are to be arranged. Change will be allowed only in exceptional circumstances. The vehicle must be available at any time/any day, as desired by the officers. As these vehicles are to be used by the Senior Officers of Press Information Bureau, the firm should ensure that all the necessary documents (Registration certificate, Insurance papers, PUC, etc.) are available with the drivers.



Their quotation should be in the following pattern.


- a) Daily charges( 80 kms. & 8 hrs) A/c or non A/c

  - c) Rate for extra km. -do-
  - d) Rate for extra hour -do-
6. The rates quoted should be inclusive of all taxes, levies etc. and valid for one year.
  7. Sealed tenders may be submitted by ~~29~~ 27-12-2006 (upto 3.00PM). The condition of the cars shall be checked by a committee constituted by this office before the financial bid is opened. The tenders will be opened on 27.12.2006 at 4.00 PM in Room No. 713, A Wing, Shastri Bhavan, New Delhi.
